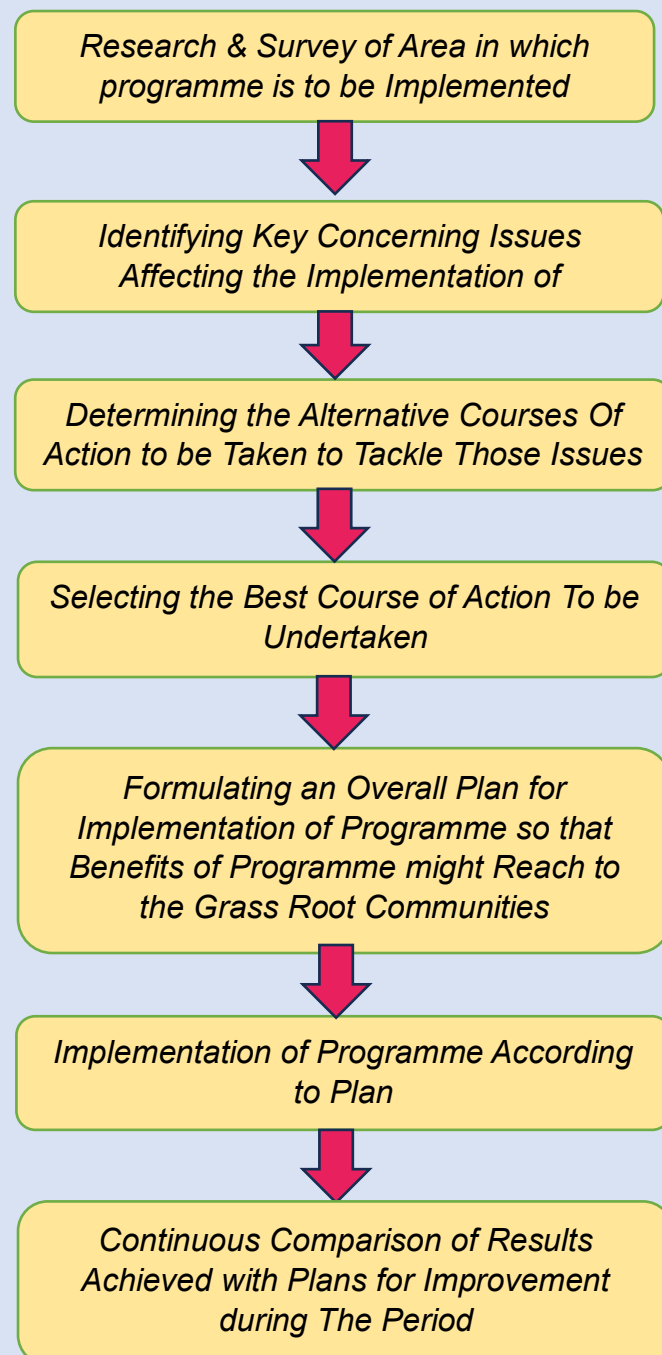

## Physical Performance

### ➤ Independence Day Celebration

On 15<sup>th</sup> August 2021 organization celebrated Independence Day at our office. In this programme about 40 people was involved. In the programme secretary of the organization and some peoples are delivered small speech on Independence Day. Flag was Raised by secretary of the organization. The Programme was organized by President & Secretary of the organization.

### ➤ Jhanki Organised on Republic Day

The organised a Jhanki on day of Republic Day on 26<sup>th</sup> January 2022 with the combination of District Social Welfare Koderma (DSW Koderma). This programme was organized on a large vehicle. In this programme about 40-50 people were involved. The program concluded at the Baghitand Stadium from the Collectorate Office.



### ➤ International Women's day Celebration

On 08<sup>th</sup> March 2022 organization celebrated International Women's Day at our office. In this programme about 30-40 people was involved. In the programme secretary of the organization and some peoples are delivered small speech on International Women's Day. The Programme was organized by President & Secretary of the organization.

## ➤ Training of Menstrual Hygiene

### 1. DISTRICT: - GIRIDIH

Organization in association with Aarohan Financial Services Limited Kolkata, West Bengal. Training was given to 2500 students in Kasturba Gandhi Balika Vidyalaya Rajdhanwar, Kasturba Gandhi Balika Vidyalaya Dumri, Girls High School Rajdhanwar, Kasturba Gandhi Balika Vidyalaya Sariya, Kasturba Gandhi Balika Vidyalaya Jamua, Kasturba Gandhi Balika Vidyalaya Birni, Kasturba Gandhi Balika Vidyalaya Gandey in Giridih district. Menstrual hygiene training was given and sanitary napkin vending machines and disposal machines were installed. And all the teachers and parents of all the students were called and given training on sanitary napkins and sanitary machines. Then those exams were also taken. And 1000 Community Members were also trained on the importance of Menstrual hygiene in Giridih district.



## 2. DISTRICT: - KODERMA

Organization in association with Aarohan Financial Services Limited Kolkata, West Bengal. Training was given to 2200 students in Kasturba Gandhi Vidyalaya Satgawan, CD Girls School Jhumri Tilaiya, Girls High School Koderma, Girls High School Domchach, Girls High School Chandwara in Koderma district. Menstrual hygiene training was given and sanitary napkin vending machines and disposal machines were installed. And all the teachers and parents of all the students were called and given training on sanitary napkins and sanitary machines.



### ➤ Nukkad - Natak

In conjunction with District Social Welfare Koderma (DSW Koderma), Nukkad Natak were performed in all the blocks of Koderma district on “**Beti Bachao, Beti Padhao**”. The people of Koderma district were very happy with this and



said that the government should bring such programs again and again so that the people of the village learn something by watching it.

## ➤ Ration Kits Distribution

The Organization in association with Jiv Daya Foundation (JDF). Ration kits were distributed two times.

### 1. August, 2021

Ration kits were distributed in 11 villages of Koderma district, in which the total beneficiaries were 375 people. Ration kits were distributed among Birhor and tribal people. The people of those villages were very happy after receiving the ration kits.



### 2. March, 2022

Ration kits were distributed in 7 villages of Koderma district, in which the total beneficiaries were 210 people. Ration kits were distributed among Birhor and tribal people. The people of those villages were very happy after receiving the ration kits.



## ➤ Wheelchairs and Tricycle Distribution

The Organization in association with Jiv Daya Foundation (JDF). Tricycles and wheelchairs were distributed among disabled people. Whose total beneficiaries were 17. Tricycles and wheelchairs were distributed among people who were unable to buy them. The beneficiary and his family were very happy with this. And the organization was also very happy to help such people.



## ➤ Milk Project

The Organization in association with Jiv Daya Foundation (JDF). Milk project was started in three villages of Saphi (Nalwa), Teliyamram and Bariyardih of Koderma district. These are villages which need development. Mostly Birhor and tribal people live in these villages. In this project, 150 children will be fed milk and given biscuits daily. And after a few days, those children were also given clothes, shoes and socks. The people of those villages were very happy with the start of this project.



## ➤ Environmental Awareness and Jaldoot Construction Project

The Organization in association with Global Greengrants Fund (GGF). Under the environmental sanitation programme, ten Jaldoots were created in ten villages who could help in cleaning and repairing ponds, wells, hand pumps etc. Saplings were distributed to 100 families to prevent water and air pollution and balance the environment in that area. Environment Day celebration was celebrated. Environmental protection training was given in all the villages. Training was given under Environment Act. People were made aware about government schemes.



### Organization Overview
